Changes to Forms

Enclosed are updated versions of the Engine Test Registration Form and the Correction of Error Form. Please note the new number located in the lower left hand corner is RSI - 940407. Discard all forms that are numbered RSI - 922403.

The ENGINE TEST REGISTRATION FORM has dashes instead of slashes for the Formulation Code under PART A and the Formulation/Stand Code under PART B. Also, the Formulation Code in PART A has been corrected to show a two character field for the test laboratory instead of five characters.

The CORRECTION OF ERROR FORM has several additions as follows:

- As indicated on the previous form only test laboratories were permitted to correct typographical or transposition errors. The revised instructions at the top of the form correct this.
- The Formulation/Stand Code field for Sponsor Code has been corrected to reflect the ten alpha-numeric character field.
- A signature and date block has been added to PART B.
  This must be signed by the individual completing the form.
