SUBJECT: Changes To Scheduling/Registration Process

Pending Change to Conformance Statement

SCHEDULING/REGISTRATION PROCESS

In accordance with the September 1992 revision of the CMA Product Approval Code of Practice, test sponsors are now required to submit Part A of the registration form to the Test Laboratory and to the CMA Monitoring Agency. All test sponsors are required to submit Part A to the CMA Monitoring Agency effective November 1, 1992. Test sponsors are asked to submit PART A on RSI's office facsimile: (210) 545-1894.

The parenthetical instruction in Part B of the Engine Test Registration Form requires the test laboratory to forward the form to the CMA Monitoring Agency and Test Sponsor. However, since the CODE does not require the test laboratory to forward the registration form to the sponsoring company, Part B of this form is being revised such that the responsibility for notifying the sponsor lies with the CMA Monitoring Agency, not the test laboratory.

To accommodate these changes, the parenthetical instructions for Part A and Part B of the Engine Test Registration Form have been revised effective November 1, 1992. A master copy is enclosed for your use. Please note the new number located in the lower left hand corner is RSI - 921026. Discard all forms that are numbered RSI - 920407.

CHANGES TO CONFORMANCE STATEMENT

Several engine test procedures only note EOT (End of Test) information and do not include the test start date and time. Since the CODE specifically requires test registration prior to test start, test laboratories will be required to place the test start date and time on the conformance sheet for all tests registered on or after November 1, 1992. Please anticipate a CMA CODE Bulletin that will include a revised conformance statement requiring this information.
