Reporting Test Results for T9 and M11 Tests

The first set of test results for registered T9 and M11 tests were received in December 1997. The test result sheets used in these reports did not provide for final soot adjusted T9 Average Liner Wear and M11 Crosshead Average Wear for candidate tests, which resulted in missing data, misnamed data and/or hand-marked notations.

To ensure the data are properly posted by RSI, laboratories must resubmit these data if forms described in TMC memo 97-257 or 97-258 were not used. The results may be submitted using the TMC forms or the enclosed short forms up through February 2, 1998. Only current ASTM TMC forms can be used after February 2, 1998.

If test results are not resubmitted as described, the fate of T9 and M11 tests will be posted as PENDING for the respective summary of scheduled tests from the CMA Monitoring Agency.
